



Montgomery County, Pennsylvania

With a diverse population that has a variety of housing needs—Montgomery County's aging population will likely bring big changes to our housing landscape. Residents ages 65 and over make up about 15% of the county's population as of the 2010 Census and will grow to nearly a quarter of the county's population by 2025. Overall, Montgomery County has seen a large increase in agerestricted housing—that is, independent living housing for those primarily over the age of 55—that has been proposed for construction or has already been built. And although some of these developments may shift to being age targeted in the future—that is to say, open to residents of all ages but still with the amenities that would appeal to older residents—the county is likely to have a steady stream of age-restricted development in the years to come.

Age-Restricted Housing Trends

This current inventory lists 105 age-restricted developments with more than 16,000 independent living units across the county. One new age-restricted development began construction in 2013. This inventory of both developments completed or significantly under construction, also includes independent units within the county's continuing care retirement communities. Nursing homes, boarding homes, personal care or assisted living developments, age targeted developments, or proposed developments not yet under construction are not included in this inventory.

Some of the trends that have come out of this inventory are:

- About half of the developments in this inventory have been built since 2000. Several developments
 have been under construction for a number of years.
- Many senior apartment complexes (and many continuing care retirement communities among them) were built in the 1970s and early 1980s.
- Much of the newer construction is in the North Penn and Indian Valley areas, in and around Franconia, Lower Salford, Hatfield, and Towamencin Townships. Older developments, not surprisingly, are in the county's more urbanized boroughs or townships that are closer to Philadelphia, such as Lower Merion or Cheltenham Townships.
- About 20 percent of the new units built in 2013 were age restricted, although most of these units
 were newly occupied units in developments that are well on their way to completion.



Age Restricted

Refers to housing developments where a legal restriction requires that all residents are 62 years of age or older or developments where at least one person (per household) who is age 55 or older lives in at least 80% of the development's occupied units.

Age Targeted

Refers to housing developments with amenities attractive to older residents or empty nesters, but without any legal restrictions on the age(s) of residents.

Assisted Living (or Personal Care) Facility

A facility in which food, shelter, and personal assistance or supervision are provided for a period exceeding 24 hours for four or more adults who are not relatives of the operator, who do not require the services in or of a long term care facility, but who do require assistance or supervision in matters such as dressing, bathing, diet, financial management, evacuation of a residence in case of an emergency, or medication prescribed for self-administration. These facilities are licensed by the PA Dept. of Public Welfare.

Continuing Care Retirement Communities (CCRCs)/Life Care

A facility which typically offers a variety of independent living arrangements for residents, together with medical and nursing services, full central dining accommodations, and educational, recreational, and social activities for those who wish to partake of them. Residents are sometimes required to pay a sizable entrance fee, as well as a substantial monthly charge, in return for all the services offered and use of their living accommodations. CCRCs are issued a Certificate of Authority by the PA Dept. of Insurance.

Independent Living Community

A housing complex—with multifamily units, attached homes, singles, or a combination of units—that is age restricted and caters to senior citizens, with minimal personal care services.

Long Term Care Nursing Home/Nursing Home

A facility licensed by the PA Dept. of Health that provides skilled or intermediate nursing care (or both) to two or more patients who are unrelated to the nursing home administrator, for greater than a 24-hour period.

Multifamily (MF)

A housing development consisting of one or more larger apartment-style buildings, with common entryways that serve the buildings' multiple dwelling units.

Naturally Occurring Retirement Community (NORC)

A NORC is an older residential development in which a large percentage of individuals aged 65 and older reside, frequently due to individuals' choice, types of units, or the long tenancy of the residents, but there is no legal requirement which mandates this.

Single-Family Attached (SFA)

Housing units in which two or more units share a vertical party wall but have individual entryways into the units; many developments with attached units have common open spaces as well.

Single-Family Detached (SFD)

Housing units which stand alone on a lot and do not share any party walls.
