- PRESS WRITE-IN SQUARE FOR THE APPROPRIATE OFFICE.

 - USING THE WRITE-IN KEYPAD BELOW, KEY IN THE NAME OF THE CANDIDATE YOU WANT TO WRITE-IN. YOU CAN SEE THE LETTERS APPEAR IN THE WINDOW.
 - IF YOU MAKE AN ERROR ON A WRITE-IN, PRESS THE ARROW KEY TO THE LEFT. TO MAKE A SPACE, PRESS THE ARROW KEY TO THE RIGHT.
 - WHEN YOU ARE FINISHED KEYING THE NAME, PRESS "ENTER" ON THE WRITE-IN KEYPAD.
