 - IF YOU MAKE AN ERROR ON A WRITE-IN, PRESS THE ARROW KEY TO THE LEFT. TO MAKE A SPACE, PRESS THE ARROW KEY TO THE RIGHT.
 - WHEN YOU ARE FINISHED KEYING THE NAME, PRESS "ENTER" ON THE WRITE-IN KEYPAD.
