- TO CAST A WRITE-IN BALLOT

- 3. USING THE WRITE-IN KEYPAD BELOW, KEY IN THE NAME OF THE CANDIDATE YOU WISH TO WRITE-IN. YOU CAN SEE THE LETTERS APPEAR IN THE WINDOW.
- WISH TO WRITE-IN. YOU CAN SEE THE LETTERS APPEAR IN THE WINDOW.
- IF YOU MAKE AN ERROR ON A WRITE-IN, PRESS THE ARROW KEY TO THE LEFT. TO MAKE A SPACE PRESS THE ARROW KEY TO THE RIGHT.
- WHEN YOU ARE FINISHED KEYING THE NAME, PRESS "ENTER" ON THE WRITE-IN KEYPAD.
